From the Desk of Pastor Katie

February. The month of Valentine's Day and something about a small rodent that predicts the weather. And this year, it's also the month when Lent begins.

Lent has always been my favorite season. Maybe it's because I like purple, but more probably it's the way that we slow things down and really seem to pay attention to what God is calling us to do and be, and how we are called to treat others.

I love Lent because it's a time of intentional penitence. It's a time when we can think about what kinds of things we might be placing before God in our lives, but it's also a beautiful, open invitation from God to learn how to live more and more as God has called us to live and be.

It seems to me that there are many passages of Scripture that are invitations to live as God calls us to live, but in true Valentine's fashion, I think the passage about love from 1 Corinthians 13 holds some heavy importance. When I heard this passage as a child, I thought it was a bit silly, to be honest, because loving people was easy. Or so I thought.

I've learned as an adult that loving people sometimes is really difficult. It's not that I think loving people, I suppose, is difficult, but perhaps the choice to love someone, no matter the circumstances, is the difficult part. And this is a lesson I've learned over and over in my life. Loving someone is easy when things are good; it's a challenge to love someone when things are difficult. And I sometimes wonder if this is how God might feel about humanity at times.

And yet, at the core of who God is resonates the choice by God again and again to continue to pour out love for humanity, for you and for me and for all human beings, without cause or explanation, without demand for payment or even recognition. God loves. Period. Again and again God loves. That's who God is.

I wonder, though, how our faith might change if we were to view that love from God as an invitation to live more boldly into the lives to which we've been called. What I mean is this: what if the love we received from God were so life-changing that our response and vocation would be to reciprocate that love and share it to the best of our human-limited capabilities? What if we took so seriously God's love that it changed the very fabric of our everyday lives and ordinary relationships? What if God's love were so radical that it transformed how we lived and worked and worshiped and played in community, both with neighbors known and unknown?

I am pondering that love this month, and I invite you to ponder with me. I invite you to remember that God's love is behind all things in life. May you hear God reminding you daily

that God loves you and has called you. May you know you are beloved by the Creator, embraced with hope, and formed for ministry in this world.

St John Lutheran Church, Maxfield Special Meeting Minutes Sunday, January 25, 2021

The St John Lutheran Church Maxfield Special Meeting was called to order by President Chuck Kaiser at 11:02 am with 27 voting members in attendance and 3 voting members present via zoom.. He shared the purpose of the meeting was to discuss and vote on four items. Item #1 was to dissolve the Unity of the Cross Parish Bremer County. Following discussion; Wanda Burkholder made a motion to dissolve the Unity of the Cross Parish Bremer County effective December 31 2020. This was seconded by Rick Wilson. Motion carried.

Item #2 was to issue a full-time letter of call to Pastor Katherine Rodriquez. Questions were asked and answered. A motion was made by Kerri Wilson, seconded by Wanda Burkholder to offer a full-time letter of call. A paper ballot showed 24 aye and 2 nay. Motion carried.

Item #3 was to approve the 2021 Compensation Package as presented by treasurer DuWayne Pipho. Paper ballot showed 24 aye and 2 nay. Compensation package was approved.

Item #4 to contract with St John Crane Creek Church for 50% of Pastor Katherine Rodriquez call for 2021 effective January 1, 2021. Motion was made by Rick Wilson and seconded by Kasey Krueger. Question was asked about mileage and the answer is that both churches will pay the IRS mileage rate for any mileage associated with their church. Motion carried.

It was moved by Annette Ebaugh, seconded by Charlene Schneider to adjourn the special meeting. Motion passed and the meeting was adjourned at 11:12 am.

St John Lutheran Church, Maxfield 2020 Annual Meeting Minutes Sunday, January 25, 2021

The St John Lutheran Church Maxfield 2020 Annual Meeting was called to order by President Chuck Kaiser at 11:13 am with 27 voting members in attendance and 3 voting members present via zoom.

Pastor Katherine Rodriquez led devotions.

The 2019 meeting minutes were approved (with a correction of the date of the previous year minutes to 2019 not 2018) following a motion by Wanda Burkholder, which was seconded by Christopher Corday.

The financial secretary report was approved as presented following a motion made by Anita Dorn, seconded by Debb Kaiser. The congregation thanked Christopher Kaiser for his work applying for and getting approved for PPP funds.

The treasurers report was approved as presented following a motion by Christopher Kaiser, seconded by Dennis Peters. The congregation expressed their appreciation to DuWayne Pipho for his service as treasurer.

The Unity of the Cross Parish Bremer County's treasurers report was approved as presented following a motion from Kasey Krueger, seconded by Wanda Burkholder. The congregation expressed their thanks to Kerri Wilson for her years as UoCPBC treasurer. The books have been closed as the Parish has been disbanded.

Pastor Katie shared the Parochial report, showing we lost four members during 2020. We ended 2020 with 136 baptized members and 121 confirmed members.

Pastor Katherine Rodriguez shared her pastor's report. The congregation appreciated her calendar graphic showing the year in review. It was an interesting year with Covid and meeting virtually for part of the year.

The President's report and committee reports (education, property care, stewardship, worship/evangelism) were reviewed as presented in the annual meeting booklet. Old Business:

Margaret Platte Estate CD. Chuck Kaiser shared that the CD is due April 18, 2021. In
February Keith Hamer with Stifel Nicholas and in March someone from Thrivent will
meet with church council to go over different options to consider. Following discussion,
the congregation will allow Church Council to make what they consider is the best
decision.

New Business:

- Budget for 2021: Anita Dorn made a motion to approve the 2021 budget as presented.
 This was seconded by Christopher Kaiser. Motion carried.
- Basement Estimate (for rental property): Kasey Krueger shared estimates we received for the work to be done on the basement of our house property. Consensus was to let Church Council select who will do the work.
- Rental Property Estimate: The outside of the rental property needs to be painted Following discussion of the estimates presented; consensus was to allow Church Council to select who will do the work.
- Election of Council Members: Debra Pipho, Chuck Kaiser and Diane Moeller's terms expired. Nominations from the floor were received for Chuck Kaiser for one more year (for continuity of Crane Creek sharing), Wanda Burkholder and Diane Moeller. Debb Kaiser moved nominations cease, this was seconded by Rick Wilson. Motion carried. Kerri Wilson moved we approve a unanimous ballot for those nominated with Chuck's term one year and the other two for three years. Seconded by Debb Kaiser. Motion carried. It was shared that next year six people go off the Council (Chuck Kaiser, Christopher Corday, DuWayne Pipho, Anita Dorn, Kasey Krueger and Annette Ebaugh).
- Appointment of Financial Secretary and Treasurer. Kerri Wilson made a motion to keep Christopher Kaiser as financial secretary and DuWayne Pipho as treasurer. Debb Kaiser seconded. Motion carried. Congregation members thanked them for agreeing to continue in those positions.
- Elect 4 Lay Representatives for Tree of Life Conference Assembly: This is to be held via Zoom in February. Christopher Corday, Christopher Kaiser and Rick and Kerri Wilson volunteered. Pastor Katie will also participate and has offered to host the group for the zoom meeting.

- Elect Two Representatives to the annual meeting of the Bartels Lutheran retirement community meeting to be held in April: Don and Mary Platte will serve.
- Elect one male, one female and one youth delegate for the NE IA Synod Assembly: To be held June 11-13, 2021 at Luther College in Decorah: Most likely this will be a virtual event. It will be important as the bishop election is on the agenda. Ardith Meier will serve as the female delegate if the meeting is virtual; Annette Ebaugh will serve if the meeting is in person. Christopher Corday will serve as the male delegate. Joe Ebaugh will be asked to serve as the youth delegate.
- Name three nominating committee members for 2021: DuWayne Pipho, Annette Ebaugh and Kasey Krueger.
- Cemetery Upkeep: Chuck Kaiser shared estimate received for stone repair. This will be done this year as time/weather permit.
- Appoint Thrivent Advocates: Wanda Burkholder and Kerri Wilson will continue to do this.
- PPP: Christopher Kaiser shared that we were eligible for the 2021 PPP funds from the government (\$7300). The Congregation thanked him for his work in securing these funds.
- School House: Discussion was held on what to do with the school house. It was decided
 that we will see what items can be donated to historical society and Poor House. Items
 that can be sold, will be sold. We will keep the sign indicating where the school house
 stood. Church Council will form a committee to take care of finalizing school house.
- LYO Funds: Christopher Corday will talk to Messiah regarding any LYO funds from the Parish. Maxfield believes the money should stay with Messiah. Chris will make sure to finalize this.
- Thank you messages were shared to those who helped with church items this year.
 Clayton Wiltse was presented with a Big Check showing the \$2,166 we received from the scrap drive he headed up. He as also presented with a new skid loader (ertl toy).
 Clayton and RuthAnn Wiltse were presented with a print of their farm to celebrate their Century Farm.
- Steffanie Krueger reminded the congregation that Viola Teisinger celebrates her 101st birthday on February 3 and cards would be appreciated.
- It was moved by Rick Wilson, seconded by Mike Richards to adjourn the meeting at 12:30 pm. Congregation adjourned following the Lord's Prayer.

These were areas that were identified as growth areas in her evaluation, so she will try to pay special attention to those areas. In addition, she is also planning to spend some time in theological areas of interest, both for personal and professional growth.




