From the Desk of Pastor Katie

What a year it has been! We've experienced so many things together as a community of faith, both when we were able to gather physically in our building, and when we've remained separated for the sake of the vulnerable in our community. As I think back on this year, I'm struck especially by the ways in which this community of faith, Maxfield, has banded together and lifted each other up in prayer and thanksgiving, leaned upon one another in times of sorrow and heartache, and especially made decisions and upheld them faithfully to the best of our ability.

If we had asked each other last year at this time if we thought life would change as much as it has, I think we both would have had a good laugh and wondered, perhaps secretly, if the other was serious in asking that question. Now, we've entered into that reality, and I think we can all say that our lives have changed beyond our wildest imaginations in the past year.

Some changes have been particularly painful, as have some of the events of this past year. We've lost four members of our congregation, and we grieve their loss to our community of faith. Especially, I think we grieve the ways in which we've had to alter how we've said goodbye.

We've walked together through the path of splitting our parish agreement with Messiah. I don't think any of us imagined that would happen, and I doubt any of us are truly happy that this is the end result. There is still heartache and hurt over those events.

We've spent more time apart as a community of faith than we have together. That, in and of itself, is challenging. I think one of the questions I asked myself over and over this year was "How are we the body of Christ when we cannot be together in the same space?" And yet, dear friends, that togetherness and unity happened, even when we were apart. As we are apart now. And may be, for who knows how long.

The constant within our lives, however, is that God's grace has remained the same. Whether we were gathered inside our building, or outside our building, or on Facebook or through emails, text messages and phone calls, God showed up and continues to show up with and among us. We are still the body of

Christ and we are still Maxfield even when we are physically distanced from one another. We are still church, and we are still church for the sake of the world.

God's grace remains the same no matter who or what we've lost in our church. God's grace has remained the same even as we've had to say goodbye to Larry, Betty, Roger and Jan through extreme circumstances. And God's grace has remained the same even as we

I cannot say with certainty what this next year holds. Well, almost. I can't guarantee what the events of the next year will be but I can say, with sure and certain hope, that no matter what we face, no matter what joys we celebrate and what heartaches we endure, no matter what may happen, God's grace, love and mercy will be the same and will embrace each and every single one of us.

And so, may we enter this new year with confidence in God's love, grace and mercy, which strengthens us, embraces us, and fills us with hope for the future. Amen.

St. John Maxfield Food Pantry

If you've happened to drive past St. John Maxfield within the past week, you might have noticed our new food pantry on the south side of the road between the church and the house. Joe Ebaugh, with the help of his family, designed and built a new pantry to replace the temporary one put up earlier this

summer. Our new pantry is located where the temporary one was, and is ready to be stocked with dry goods for the winter season. We are requesting donations of things like powdered laundry soap, bar soap, and non-perishable dry goods like boxed cereal and pasta, dried beans, boxed dinner kits (Hamburger Helper, etc.), macaroni and cheese, and other such items. As always, paper goods like toilet paper, paper towels, and Kleenex are welcome, as are diapers! We are also asking for canned goods to be donated, which will be held in the church and available for those who need it. We cannot place canned goods, or liquid soaps/wipes or cleaning supplies in the pantry during the winter months, as they will freeze, but we are still hoping to provide those items for the needy in our community. Special thanks to the Ebaugh family for this beautiful contribution to the ministry of our church. We are grateful for their willingness to serve in this way! As many of you know, this year has been challenging for so many people, and the pantry has been utilized regularly. We want to continue to provide assistance for those in this community who have benefited from the pantry. Please prayerfully consider supporting this vital ministry of our church! 

Pastor Katie was also present.

Pastor Katie opened the meeting with devotions.

Minutes of the November meeting were approved as presented following a motion by Anita Dorn and a second by Christopher Kaiser.

The November Financial Secretary's report was approved as presented following a motion by Rick Wilson and a second by Dennis Peters.

The November Treasurer's report was approved as presented following a motion by Christopher Kaiser and a second by Kasey Krueger.

Pastor's Report

Because of technical problems, Pastor Katie is now prerecording and editing the Sunday morning worship services to be set to view at 10:00 am on Sunday morning on FaceBook.

Pastor Katie met with members of Crane Creek and Maxfield to discuss contracting 50% of Pastor Katie's call.

Has been making phone calls to Maxfield members.

President's/Property Care Report

Kasey Krueger got bids for insulating the parsonage (rental property) foundation. Council decided to table discussion until annual meeting, but will include the cost of insulating on the 2021 budget.

DuWayne set up the nativity scene.

Education Report

The motion to give any money left in the Unity of the Cross Parish LYO fund to Messiah was approved after a motion by Annette Ebaugh and a second by Rick Wilson.

Worship/Evangelism

The committee met via zoom and planned worship thru January. There was discussion on whether to have Christmas Eve Service.

Stewardship

There was some discussion on what we are going to do with the Margaret Platte money. We decided to contact Keith Hamer (Investment Representative) as well

as a representative from Thrivent to come and talk to the church council in February. This will also be discussed at the annual meeting.

Old Business

A motion was approved to give Christopher Kaiser and Cindy Clemen \$500 for setting up the church website (www.stjohnmaxfielddenver.org) after a motion by Rick Wilson and a second by Christopher Corday.

New Business

We received a check for \$1,000 from the Denver Savings Bank to help those in need in our congregation.

DuWayne presented the budget for 2021. The budget was approved after a motion by Christopher Kaiser and a second by Kasey Krueger.

Discussion with Crane Creek to contract 50% of Pastor Katie's call has gone very well. Crane Creek was very receptive and would like to go ahead with the contract beginning January 1, 2021.

The following motions were approved and need to be presented to the congregation for a congregational vote:

The motion was made by Annette Ebaugh and seconded by Dennis Peters and approved to waive the 6 month notice and dissolve the Unity of the Cross Parish Bremer County effective immediately through mutual agreement with Janesville Messiah.

The motion was made by Anita Dorn and seconded by Annette Ebaugh and approved to call Pastor Katie Rodriguez to a full time call effective January 1, 2021.

The motion was made by Rick Wilson and seconded by Christopher Kaiser to approve Pastor Katie's compensation package for 2021.

The motion was made by Annette Ebaugh and seconded by Christopher Corday to enter into an agreement with Crane Creek to contract 50% of Pastor Katie's call to Crane Creek effective January 1, 2021 through December 31, 2021 with Maxfield and Crane Creek each paying for the pastor's mileage that pertains to each church.

The January church council meeting will be on January 10.

The annual meeting will be held on January 17 immediately following the worship service.

Meeting adjourned with the Lord's Prayer at 12:10 pm following a motion by Rick Wilson and a second by Diane Moller.

Continues live streaming of Sunday morning worship and discussed with the council when to stop in church worship because of the spike in Covid numbers. Pastor Katie and the church council will decide on a week by week basis.

President's/Property Care Report

The old garage has been pulled down and will be burned in the near future.

The school house is in really bad shape and the future of the building and contents will be discussed at Maxfield's annual meeting in January.

The organ tuner will be coming to tune the organ on November 12.

Church Mutual sent the church sensors that can be placed in the church to detect the temperature and possible water leak in the church. It has been installed on DuWayne's phone and the two sensors have been placed in the church; one in the furnace room and one on the book shelf in the fellowship hall.

A motion was made by Annette Ebaugh and seconded by Christopher Kaiser and approved to transfer \$4,577.96 from the capital improvement fund to the general fund to cover the costs of the parsonage painting, paint, pressure washing, garage doors and openers, moving the LP tank, and the dumpster.

Anna Richards also applied and received a LYO scholarship.

Chuck Kaiser will contact the president of Crane Creek, Lee Schweer to see if there is any interest in a shared Pastor agreement.

There was discussion about the procedure to dissolve the Unity of the Cross Bremer County Joint Parish. It was decided to table any further discussion until our December meeting.

New Business

Because of concern and safety for the congregation the council has suggested a 2:00 pm Christmas Eve afternoon in-church worship service and a 7:00 virtual candlelight service. This is subject to change so please watch for emails.

Anita Dorn will check with Toby Pencil to see if he is interested in snow removal again this year.

We have been asked if the AA group could use our church for their monthly meeting. Council agreed.

The December church council meeting will be December 6, 2020 following worship.

Pastor's Report

Old Business

A motion was made by Anita Dorn, seconded by Christopher Corday, and approved to transfer \$750 from the kitchen fund to the general fund to cover scholarships. Those from our church to receive scholarships were John Ebaugh, Eli South, and Chase Lyons.

The money received from the synod for feminine hygiene products will be used to stock our Little Food Pantry.

Christopher Corday will do the final walk through of the parsonage and will handle the lease agreement with Pastor Katie and Brandon.

Water usage for the parsonage will be included in the amount paid for rent.

Mr Mehmen contacted Chuck about stone repair in the cemetery. He felt there were at least 35 stones that needed to be reinforced, and the amount to repair them would be \$4200. This will be discussed with the congregation at the annual meeting.

Compared quotes from Brotherhood Mutual and Church Mutual and decided that for the difference we would stay with Church Mutual.

New Business

Deb Pipho received a call from Mary at the Denver Savings Bank and she was wondering if we received the banks \$1000 gift to our church for those in need in 2019. They sent the check and it was never cashed. No one on the council or Pastor Katie knew anything about it, but the check was never received or cashed so they issued us another check for \$1000.

A motion was made by Christopher Corday and seconded by Rick Wilson and approved to give Pastor Katie \$150 in gift cards in \$20 increments from Brothers Grocery Store and \$150 in gift cards in \$20 increments from Kwik Star using money from the Denver Savings Bank to be placed in Pastor Katie's "Pastor's Discretionary Crisis Fund" to be given to those in need as Pastor Katie sees fit.



Duke Home & Lawn LLC was hired to pressure wash the parsonage, A motion was made by Rick Wilson, seconded by Kasey Krueger, and approved to transfer money from the capital improvement fund to the general fund to pay for the pressure washing of the parsonage. While pressure washing the parsonage some of the paint came off of the siding. K & K were contacted to see how much they would charge to paint the outside of the house. Their bid was for \$2500. Because of the amount of the bid it was decided to include it as budget item to be voted on by the congregation.

Kasey Krueger will check to see how much it would cost to spray the foundation.

The church listing in the Forum needs to be updated.

The November church council meeting will be November 8, 2020 following worship.

Meeting adjourned with the Lord's Prayer at 11:30 am following a motion by Anita Dorn and a second by Kasey Krueger.
